## Cases referred to independent Mediators through Building Management Mediation Co-ordinator's Office from 01/01/2023 to 31/12/2023

In 2023, a total of 57 cases have been referred to mediators by the BMMCO. As at 31 December 2023, mediation has been conducted and completed in 48 cases, of which 15 have been settled after mediation. The success rate, based on cases completed, is 31%. The average duration between the date of appointing mediator to the date of completion of the whole mediation process, on average, is 46 days.

Over average, it took 6 hours to reach a full agreement, 3 hours to reach a partial agreement and 4 hours to reach no agreement.

Regarding the cost of mediated cases, in year 2023, only 5 of them appointed fee-charging mediators. Of which, two cases with full agreement cost HK\$1,900 / HK\$200 per hour; one case with partial agreement cost HK\$2,300 / HK\$800 per hour; and two cases without agreement, the average cost was HK\$4,000 / HK\$1,000 per hour.

According to the record kept by BMMCO, 95% cases appointed mediators who offer mediation services on a pro-bono basis.
